impacts of Adverse Childhood Experiences experienced by families with family justice issues. #2 Our primary strategy is to transform the family justice system by centring children, youth

and families, seeing the system from their perspective, and focusing on family well-being. **#3** We align efforts across justice & other sectors to objectives in our <u>TFJS strategy map</u>.

#4 Led by <u>Access to Justice BC</u>, we have many diverse volunteer participants working with us.

#5 We are guided by 8 principles: Equitable, Strengths-based, Emphasizing Relationships, Child-centred, Supportive of agency, Holistic, Preventative, & Trauma-informed.

I am an Anishinaabe Elder. Anishinaabe on my Father's Side, from the Batchwana Band, on the Garden River Territory in Ontario. Both my grandparents on my Mother's Side are from a small town in Sweden where our cousins the Sami People, the indigenous people of Sweden, live.

I am honoured and excited to be part of a wonderful group of like-minded people, who are working in unity, from their holistic selves, to de-colonize two of the biggest, most powerful systems in the world. One heart, one mind, one people.



Support Finder

This CoA champions connecting families to the supports they need. It seeks to leverage technology to reduce stress and maximize the opportunities for early, appropriate and holistic resolution.



Intersectoral Family Justice

This CoA champions overcoming barriers and implementing a preventative, intersectoral approach to supporting families with family justice (including child protection) issues. It promotes a shift from centralized silos to integrated services at the community level.
